PROJECT DESCRIPTION

The Foster Mountain Ranch consists of 3,829 acres adjacent to the Sanhedrin Wilderness. The property is located approximately 8 air miles northwest of Willits on the southwest side of the Eel River in Mendocino County. Elevations of the ranch range from 1,352 feet above sea level on the Eel River to approximately 3,120 feet at the top of Foster Mountain on the western property line. The Eel River runs along the eastern boundary and through the northeast portion of the ranch. Foster Mountain Ranch is one of three (the others being Garcia Creek Ranch and Summer camp) properties within the watershed being funded for conservation easements. CAL FIRE is acquiring the property as a conservation easement for the purpose of protecting forest and rangeland uses including wildlife habitat, watershed stabilization and the continued production of forest products. The federal Forest Legacy Program was created with clearly delineated open-space conservation goals and objectives to protect environmentally important private forest lands threatened with conversion to non-forest uses pursuant to Section 1217 Title XII of the Food, Agriculture, Conservation and Trade Act of 1990 (16 U.S.C. Section 2013C). Congress has awarded a Forest Legacy Program grant to CAL FIRE in order to aid in the purchase of the easement conveyed for conservation of forested, agricultural and open-spaced land.

PROJECT DESCRIPTION

The Garcia Creek Ranch consists of 4,779 acres contiguous to the Sanhedrin Wilderness in Mendocino County. The property is located approximately 9 air miles northeast of Willits on the north side of the Eel River in Mendocino County. The property consists of 6 Assessor's Parcels ranging from 38 acres to 2,221 acres. Garcia Creek Ranch is one of three (the others being Foster Mountain Ranch and Summer camp) properties within the watershed being funded for conservation easements. CAL FIRE is acquiring the property as a conservation easement for the purpose of protecting forest and rangeland uses including wildlife habitat, watershed stabilization and the continued production of forest products. The federal Forest Legacy Program was created with clearly delineated open-space conservation goals and objectives to protect environmentally important private forest lands threatened with conversion to non-forest uses pursuant to Section 1217 Title XII of the Food, Agriculture, Conservation and Trade Act of 1990 (16 U.S.C. Section 2013C). Summer Camp consists of 7,012 acres contiguous to the Sanhedrin Wilderness in Mendocino County. The property is located approximately 9 air miles northeast of Willits on the north side of the Eel River in Mendocino County. Elevations on the ranch range from approximately 1,400 feet above sea level near the Eel River to approximately 4,480 feet near Bald Mountain on the high northeast portion of the ranch. Summer Camp is one of three (the others being Foster Mountain Ranch and Garcia Creek Ranch) properties within the watershed being funded for conservation easements. CAL FIRE is acquiring the property as a conservation easement for the purpose of protecting forest and rangeland uses including wildlife habitat, watershed stabilization and the continued production of forest products.
