Recommendations for committee assignment are subject to revision by a standing committee or the Board. This list does not include items raised by CAL FIRE. Other issues that may be considered in the selection of 2017 priorities may be:

- 1) AB 2029 and the Forest Fire Prevention Pilot Project (14 CCR 1038, already underway in FPC/MGMT committee;
- 2) Aspen, meadow and wet are restoration (14 CCR 913.4(e));
