## **MONTHLY BOARD REPORTS**

### **Report of the Chairman.**

- Congratulated Mr. Dias on his appointment to Executive Officer of the Board of Forestry and Fire Protection.
- Welcomed Darcy Wheelles as a member of the Board.
- Provided an update on Forest Carbon Action Team (FCAT).

### **Report of the Director/Department. Chief Deputy Director Janet Barentson**

Director Pimlott is visiting a number of the large fires that are burning throughout the state, in particular the Cedar Fire, with members of congress and the U.S. Forest Service (USFS).

#### **Fire Statistics**

To date there have been a significant number of fires, 4,000 fires with 150,000 acres burned. It is a 21% increase in wildfires from the previous year. There has been an uptick in wildfires consistent with the drought and fuel moisture. CAL FIRE is anticipating that fire activity is going to continue to increase. They continue to have the Governor's support with drought staffing that allows catching most fires before they go into an extended attack. Notably the fires are burning faster; the ignition rate is as high as 97% for spotting embers. CAL FIRE is looking at suppression tactics; they have not been fighting wildfires in the same manner as has been done in the past. Their suppression goal remains with 90% at 10 acres or less and they are analyzing where to safely place firefighters and where to make the initial attack stand.

CAL FIRE is focusing upon the Ready Set Go campaign as a result of firefighters spending significant amounts of time during initial attack on assisting evacuees. The Communications staff continues to work on public service announcements and social media outreach with the goal of informing the public on being ready to evacuating early during a wildfire.

CAL FIRE announced the arrest of the arsonist who caused the Clayton fire, at least 16 other fires are also attributed to him; also announced the cause of the Valley Fire, the cause was faulty wiring of a spa that arced onto grass. The decision to prosecute has not been determined.

#### **Budget**

The Senate announced their Cap and Trade plan, \$30 million for Urban Forestry and \$20 million for Forest Health. The Cap and Trade auction took place the day before the Board meeting, the Senate had until the end of the week to come up with a plan.

#### **SRA and Tree Mortality Grants**

Grant guidelines have been developed; the application period opened August 23<sup>rd</sup> and will close in September. Anticipated awards to be made sometime in the fall or early winter.

#### California Forest Carbon Plan

The Draft Plan has been routed for FCAT member's input. Public input meetings are planned for late September, early October. The Draft Plan is on track for a final in December. They are going over public comment and are addressing those comments in the plan.

#### USFS Budget

The Director continues to weigh in on behalf of the state on the USFS fire borrowing and fire budget issue. He is working with members of congress and CAL FIRE's congressional liaison in Washington DC, however congress is out of session until the end of September and it is not likely they will make a change in the USFS budget this session. It is anticipated there will be a continuing resolution to move the federal budget forward and CAL FIRE looks forward to addressing this issue again in spring.

**Presentation of the Francis H. Raymond Award:** The award was named after Francis H. Raymond who was the Director of the California Department of Forestry and Fire Protection from 1953 to 1970, and was one of the primary advocates for the passage of the Professional Foresters Law in 1973. Since 1987 it has been awarded to a group or individual who has achieved excellence in the field of forestry in California.

The Francis H. Raymond Award was presented to Dr. Douglas D. Piirto, RPF #2179, and the California Society of American Foresters (SAF). Julie Lydick accepted the award on behalf of SAF.

### **SPECIAL BOARD HEARINGS/REPORTS**

**Presentation:** 63 million and Counting: Implications of a Massive Tree Mortality Event on Carbon Maintenance and Forest Management – Chris Fettig, Research Entomologist, Pacific Southwest Research Station.

Public Comment:

**Eric Carelson, Associated California Loggers**, spoke to the need for landowner assistance the readiness of the LTO community to assist in solving the problem faced by the state in regards to the rampant drought mortality.

**Hearing (Initial): Utility Notice of Overhead Operations Amendments, 2016.** The effect of this proposed action will prescribe additional conditions requiring disclosure upon a Notice of Intent pursuant to 14 CCR §1032.7, specifically, whenever any overhead powerlines lie inside or within 200 feet of a new or amended plan boundary.

No action was taken. The Board directed staff to prepare the Final Statement of Reasons for consideration at the September Meeting.

**Hearing (Initial): Working Forest Management Plan:** Assembly Bill 904 created the Working Forest Management Plan (WFMP) program. The WFMP is a long-term forest management plan available to nonindustrial landowners (with less than 15,000 acres of timberland) if they commit to uneven aged management and sustained yield.

Executive Officer Dias gave an overview of the Working Forest Management Plan and written comment received during the 45-Day public notice period.

Public Comment:

**Alan Levine, Coast Action Group**, commented the group would approve and support an idea of a long term plan document or mechanism that would provide certain results, however, the current language does meet that level. The wording in the WFMP needs to be consistent with the intent of AB 904 and all other California codes and regulations. Coast Action Group is asking the Board not approve and to reconsider the language as proposed and is willing to meet to discuss ways to resolve the issues.

**Rob DiPerna, EPIC**, submitted handout with bullet points of the issues they feel need to be addressed. Referred to a letter that was submitted to Professional Forester's Licensing by Chris Moranto regarding PRC 752(b).

**Richard Gienger, Forests Forever**, commented that an effort has not been made to make a professional document that would outline performance standards that would be transferrable from generation to generation or from year to year. There's a need for an adequate format for describing conditions, restoration and management of the lands in an understandable manner, now and in the future. He is skeptical of the implementation of 14 CCR § 916.4, there's a standard format that is to be adhered to for a consistent description of the conditions, impacts and restoration opportunities in watercourses. If there is a plan in place in perpetuity there has to be a commitment to it, it needs to be spelled out. He gave an example of the difficulty of passing it to the next forester or LTO and it be easily understood.

**Larry Camp, Forest Landowners of California**, explained his involvement with developing the language for the plan and commented he doesn't recall a discussion regarding being limited to a single landowner. It was his impression that it would apply in a similar way to the NTMP that multiple landowners could band together to put together a management plan with a light touch on the landscape.

No action was taken. The Board directed staff to prepare the Final Statement of Reasons for consideration at the September Meeting.

**Hearing (Initial): Less than 3 Acre Conversion Amendments, 2016.** The purpose of the proposed action is to enable landowners to proceed with a Conversion Exemption where significant archeological site(s) exist. Currently regulations (14 CCR § 1104.1(a)(2)(I)) strictly prohibits the use of a Conversion Exemption where timber operations take place on a significant archeological site as defined in 14 CCR § 895.1.

Public Comment:

**Penny Rassmussen, member of the public**, expressed her frustration on the timeline that the Board has taken to address this issue and the seemingly inequitable treatment of her project by CAL FIRE in regards to others in her neighborhood. She urged the Board to move expediently to have an effective date of the regulation by January 1, 2017.

Public Comment:

**Bill Solinsky, Forest Practice**, commented that once it's converted it's just the trees that are removed, there are trees left standing or when regeneration comes in that still becomes timberland and requires an additional conversion.

**Richard Gienger, Forests Forever**, commented that a conversion exemption should not have been required in this situation. He asked if the conversion could be rescinded and capped to move forward so that the issue could be resolved and subsequently deal with the greater issues and procedures.

No action was taken. The Board directed staff to prepare the Final Statement of Reasons for consideration at the September Meeting.

## CONCLUSION

### Public Forum

**Eric Carleson, Associated California Loggers**, gave an update on RPF, LTO responsibilities. Also shared his concerns regarding the FPC and RPC meetings scheduled at the same time, he requested that if possible that future meetings should be scheduled separately so they can be attended without any conflict. Chair Gilles explained for the purpose of the workshop the committee meetings had to be scheduled in that way.


**Richard Gienger, Forests Forever**, Menlo Dam taken out of the South Fork Eel. 19<sup>th</sup> Annual Coho Confab, August 26 - 28, 2016. Sanctuary Forests public hike, Big Red: Ancient Redwood September 10. Lost Coast Forest recently purchased 700 acres on the South Fork Eel River. They are pursuing educational opportunities. He is pleased to see progress of interviewing individuals for teams for the first pilot project in the Campbell Creek Watershed Project.

**Dave Fowler, North Coast Regional Water Quality Control Board**, spoke in response to a Board question to display his agency's support of the WFMP draft regulations, the Board's process to get to the regulatory proposal and recognition of the fact that the North Coast Regional Water Quality Control Board comments were not consistent with the legislative mandate of PRC 4597 *et seq.*
