### Report of the Chairman.

### Report of the Director/Department.

- Departmental Succession and recent appointments:
  - Matt Reischman – Assistant Deputy Director Resource Management
  - Joe Tyler – Assistant Deputy Director, Fire Protection
  - Marc Hafner – Unit Chief Tulare
- Year to Date Fire Stats
  - The Valley and Butte Fires have become the 5<sup>th</sup> and 7<sup>th</sup> most damaging fires in the state's history. The year 2015 concluded with over 6,300 fires on State Responsibility lands, that is 1,800 fires more than the 5 year average with 307,600 acres burned. Even with the increased workload the Department maintained a 95% initial attack success rate at 10 acres or less.

- Total Department budget within the State's Draft Budget is \$2.1 billion which includes:
  - \$17 million in permanent increases for Emergency Command Center staffing across the state.
  - The Department is funded for Automatic Vehicle Locating system, this system will allow for real time two way interactivity between Cal Fire resources and command control framework.
  - An update was provided on proposed Information Technology staffing per draft budget.
  - \$180 million is proposed for Green House Gas reduction.
  - Professional Standards unit has been funded within the draft budget. This internal unit wouldwork to initiate a program to support progressive discipline, adverse actions and prevention with personnel procedures policy training to address disciplinary issues.
  - Replacement of helicopter airframes.
- Tree Mortality Task Force has identified of eight sub working groups to address the Emergency Proclamation.
- Prescribed Fire MOU will be released during a press conference on February 2, 2016.
- An update on State Responsibility Area Grant Approvals was provided.
- An updated on Green House Gas Reduction Project Status was provided.
- Forest Climate Action Team (FCAT) update.
  - Policy group working on a modified outline for Forest Carbon Plan concept paper.
  - The concept pater will be used to provide input into the Updated Scoping Plan process.
- Emergency Watershed Assessment
  - All projects identified, primarily focused at controlling surface erosion, for the Valley Fire, and most all on the Butte Fire have been completed.
  - Assessment Teams have shut down and turned projects over to the Unit.
