

1 **1091.4 Sustained Yield Plan Contents**

2 (a) **Contents of SYP** ~~If a SYP is submitted, it~~ A SYP may submitted at the discretion of the timber
3 and timberland owner and shall be prepared under the supervision of and signed by an RPF. A
4 Sustained Yield Plan, Form Number ## and shall include contain the following information:

5 (1) Name and Address of timber and timberland owner.

6 (2) Ownership description and location, including legal descriptions and maps depicting the
7 ownership and Management Units which shall be at a scale sufficient to allow the Director to
8 determine the area covered by the SYP.

9 (3) Management objectives for resources addressed in the SYP, including timber products.

10 (4) General narrative description of the forest types, fish and wildlife habitats and watercourses
11 and lakes.

12 (5) Descriptions of Management Units (e.g., planning watersheds or larger areas) and rationale
13 for Management Unit selection.

14 (6) Identification and mapping of Planning watersheds classified as sensitive watersheds and
15 description of the measures taken to protect resources within those watersheds.

16 (7) **A checklist for inclusion with THP submissions that identifies specific mitigation**
17 **measures or requirements described in the SYP, in addition to the standard Forest Practice**
18 **Rules, that are to be implemented in THPs tied to the SYP. Such measures or requirements**
19 **may include, but are not limited to specific resource protection measures; fish, wildlife, or**
20 **botanical surveys; standardized road and tractor trail crossing specifications; and standardized**
21 **erosion control procedures, among others.**

23 **1091.9 SYP Effective Period**

24 The effective period of a SYP shall be no more than ten years. Renewal of a currently approved SYP
25 may be granted for an additional ten year period upon review and approval of the Director pursuant to
§1091.15.

1
2 **1091.15 Renewal of Sustained Yield Plans**

3 A currently approved SYP may be renewed for an additional ten (10) year period subject to the review
4 and approval of the Director. The Director's determination shall be based upon multi-disciplinary
5 review and evaluation of the elements of the SYP renewal submission to determine if the SYP renewal
6 satisfies the requirements of MSP, identifies potentially significant adverse impacts, and includes
7 feasible mitigation measures for avoidance of such impacts. **The plan submitter is encouraged to**
8 **pre-consult with review team agencies prior to submission of a proposed SYP renewal.**

9
10 (a) Within 20-days of the receipt of a SYP renewal submission (utilizing SYP Form No. ###), the
11 Director shall determine if the SYP renewal is complete, accurate, and in proper order. If so, the SYP
12 renewal shall be filed. If the SYP renewal is not acceptable for filing, the Director shall return the SYP
13 renewal with a written explanation of the deficiencies. Where the Director does not make this
14 determination within 20-days, the SYP renewal shall be deemed filed.

15
16 (b) Once the SYP renewal has been filed, the Director shall have 45-days or longer as mutually agreed
17 to by the submitter to **conduct a review of the proposed SYP renewal. and make a determination**
18 **of conformance.**

20 (c) Public Notice of SYP Renewal. The Director shall transmit notice to the public and agencies
21 consistent with the noticing requirements of §1037.5 and §1037.1b(1-5). The Notice shall advise the
22 public of the name of the submitter, geographic location of the SYP, location(s) where a copy of the
23 SYP can be reviewed or obtained, and when and where the public hearing will be held.

1 (d) Public Hearing. The Director shall hold a public hearing on the SYP renewal within 30-days from
2 the start of the public review period. The SYP renewal submitter shall participate with the Director in
3 that hearing.

4
5 (e) Director's Determination Period. At the end of the public review and comment period, the Director
6 shall have 10-days to review public input, consider recommendations and mitigation measures of other
7 public agencies, respond in writing to the issues raised, and determine if the SYP renewal is in
8 conformance with the rules. If the SYP renewal is found to be in conformance, it shall be approved by
9 the Director.

10
11 (f) SYP Renewal Disapproval. If the Director disapproves a SYP renewal, the Director shall provide
12 written reasons for disapproval that conform with §1054. **Appeal of the Director's decision on an**
13 **SYP renewal submission shall be conducted pursuant to §1091.11.**
