There currently exists two (2) vacancies with the Range Management Advisory Committee (RMAC); an advisory committee to several government entities including the State Board of Forestry and Fire Protection. The purpose of this notice is to solicit nominations for consideration by the Board of Forestry and Fire Protection for appointment to RMAC.

Nominations are needed for the following:

- One** (1) member representing the California Forestry Association
- One** (1) member representing the California Farm Bureau Federation

Board authority for appointments to RMAC is found within Section 741 of the Public Resources Code. The composition of RMAC is determined by statute and the RMAC Strategic Plan adopted by the Board January 2000. RMAC serves in an advisory capacity on rangeland resource issues to the Board, the Secretary of the Resources Agency, the Secretary of Food and Agriculture, and the Secretary for Environmental Protection. The Committee is composed of 11 members; nine are from specified organizations and two members are from the general public.

RMAC members serve a four-year term, and will normally meet 4-6 times per year. Committee members serve without compensation except for travel expenses. The Board will appoint persons from the list of nominees. Appointments may be made during the March, 2008 Board meeting or at a later date pending Board consideration of the nominees.
