The Board of Forestry and Fire Protection proposed this action to amend sections 913.4 and 933.4 of title 14 of the California Code of Regulations, which are applicable to the Coast Forest District and the Northern Forest District, respectively. The purpose of the amendments is to provide flexibility to landowners to better manage stands of Oregon white oak and California black oak in which conifer species are encroaching.

OAL approves this regulatory action pursuant to section 11349.3 of the Government Code. This regulatory action becomes effective on 1/1/2017 pursuant to section 4554.5 of the Public Resources Code.

OAL hereby returns the rulemaking record your agency submitted for review regarding "White and Black Oak Management Special Prescription."

If this is an approved matter, it contains a copy of the regulation(s) stamped "ENDORSED APPROVED" by the Office of Administrative Law and "ENDORSED FILED" by the Secretary of State. The effective date of an approved regulation is specified on the Form 400 (see item B.5). **Beginning January 1, 2013**, unless an exemption applies, Government Code section 11343.4 states the effective date of an approved regulation is determined by the date the regulation is filed with the Secretary of State (see the date the Form 400 was stamped "ENDORSED FILED" by the Secretary of State) as follows:

- (1) **January 1** if the regulation or order of repeal is filed on September 1 to November 30, inclusive.
- (2) **April 1** if the regulation or order of repeal is filed on December 1 to February 29, inclusive.
- (3) **July 1** if the regulation or order of repeal is filed on March 1 to May 31, inclusive.
- (4) **October 1** if the regulation or order of repeal is filed on June 1 to August 31, inclusive.

If an exemption concerning the effective date of the regulation approved in this matter applies, then it will be specified on the Form 400. The Notice of Approval that OAL sends to the agency will include the effective date of the regulation. The history note that will appear at the end of the regulation section in the California Code of Regulations will also include the regulation's effective date. Additionally, the effective date of the regulation will be noted on OAL's web site after OAL posts the Internet Web site link to the full text of the regulation that is received from the agency. (Gov. Code, secs. 11343 and 11344.)

Please note this new requirement: Unless an exemption applies, Government Code section 11343 now requires:

1. **Section 11343(c)(1):** Within 15 days of OAL filing a state agency's regulation with the Secretary of State, the state agency is required to post the regulation on its Internet Web site in an easily marked and identifiable location. The state agency shall keep the regulation posted on its Internet Web site for at least six months from the date the regulation is filed with the Secretary of State.
2. **Section 11343(c)(2):** Within five (5) days of posting its regulation on its Internet Web site, the state agency shall send to OAL the Internet Web site link of each regulation that the agency posts on its Internet Web site pursuant to section 11343(c)(1).

OAL has established an email address for state agencies to send the Internet Web site link to for each regulation the agency posts. Please send the Internet Web site link for each regulation posted to OAL at postedregslink@oal.ca.gov.

NOTE ABOUT EXEMPTIONS. Posting and linking requirements do not apply to emergency regulations; regulations adopted by FPPC or Conflict of Interest regulations approved by FPPC; or regulations not subject to OAL/APA review. However, an exempt agency may choose to comply with these requirements, and OAL will post the information accordingly.

DO NOT DISCARD OR DESTROY THIS FILE

Due to its legal significance, you are required by law to preserve this rulemaking record. Government Code section 11347.3(d) requires that this record be available to the public and to the courts for possible later review. Government Code section 11347.3(e) further provides that "...no item contained in the file shall be removed, altered, or destroyed or otherwise disposed of." See also the State Records Management Act (Government Code section 14740 et seq.) and the State Administrative Manual (SAM) section 1600 et seq. regarding retention of your records.

If you decide not to keep the rulemaking records at your agency/office or at the State Records Center, you may transmit it to the State Archives with instructions that the Secretary of State shall not remove, alter, or destroy or otherwise dispose of any item contained in the file. 9 **§ 913.4 [933.4] Special Prescriptions.**

10 The following special harvesting methods are appropriate under certain conditions:*****

11 *****

12 (f) White and Black Oak Woodland Management. Timber harvest within certain
13 deciduous oak woodlands, forests, and savannahs as described herein may occur as
14 necessary to restore or conserve the ecological, cultural, and economic values of these
15 historically oak-dominated stands. The silviculture shall be designed to reduce water,
16 light, and nutrient competition from Group A species in order to promote the sustained
17 viability of Oregon white oak and California black oak stands. Group B species including
18 white and black oaks may also be harvested. The use of this prescription shall be
19 designed to balance the contribution of resource values attributable to Oregon white oak
20 and California black oak stands with the other goals of forest management specified in
21 14 CCR § 897, and shall meet the following requirements:

22 (1) The prescription may be applied to stands in which Oregon white oak
23 (*Quercus garryana*) and/or California black oak (*Quercus kelloggii*) meet or exceed,
24 preharvest, an average of 35 square feet of basal area per acre.

1 (2) The RPF shall provide a description of the stand for which the special
2 prescription is to be applied including:

3 (A) An estimate, by species, of pre-harvest stand composition, diameter
4 distribution, and basal area.

5 (B) A description of natural and any known anthropogenic factors
6 conducive to Oregon white oak and/or California black oak historic and sustained
7 occupancy of the site. This may include discussion of climate, soil, light, aspect, fire
8 regime, management practices, or other relevant factors.

9 (C) A description of any apparent or known trend in changing stand
10 composition occurring over time and the factors likely to be contributing to this trend.

11 (3) The RPF shall provide a description of the planned post-harvest stand
12 condition including, by species, desired stand composition, diameter distribution, and
13 basal area.

14 (4) The RPF shall describe what trees are to be harvested and the method by
15 which those trees shall be identified, as well as any special instructions to the LTO
16 regarding measures to be taken to protect residual oak trees during timber operations.
17 If trees are to be identified by the method of marking, they shall be marked by, or under
18 the supervision of, an RPF prior to harvest. A sample area must be marked prior to the
19 preharvest inspection for evaluation. The sample area shall include at least 10% of the
20 harvest area to a maximum of 10 acres per stand type which is representative of the
21 range of conditions present in the area. The Director may waive the requirements for
22 the remainder of the area when explained and justified by the RPF in the THP.

23 (5) The RPF shall describe how the boundaries of the special prescription shall
24 be identified and, prior to the preharvest inspection, the special prescription boundaries
25 shall be identified on the ground, under the supervision of an RPF.

1 (6) Decadent and Deformed Trees of Value to Wildlife shall be retained unless
2 they pose a safety hazard or are explained and justified by the RPF as to why removal
3 is necessary to facilitate timber operations or the objectives of the harvest or special
4 prescription.

5 (7) Immediately upon completion of timber operations, the post-harvest stand
6 shall contain Oregon white oak and/or California black oak stocking levels that meet or
7 exceed an average of 35 square feet of basal area per acre.

8 (8) Immediately upon completion of timber operations, Group A species shall not
9 exceed 50 percent of the combined Group A and B species post-harvest stand basal
10 area. Oregon white oak and/or California Black oak stocking levels shall not be reduced
11 proportionally relative to Group A species as a result of the harvest.
